# **CES Faculty Win Teaching and Scholarship Enhancement Awards**

We are very happy to announce that three of the Center for European Studies faculty members, Dr. Ewa Wampuszyc, Dr. Christopher Caes and Dr. Hana Filip, have won competitive University of Florida awards for their teaching and research accomplishments. Dr. Christopher Caes and Hana Filip have been awarded the Humanities Scholarship Enhancement Funding for their proposed research projects, while Dr. Ewa Wampuszyc has won the prestigious 2005-06 College of Liberal Arts and Sciences Faculty Teaching Award.



Eligibility for the CLAS Teaching Award is based on an outside nomination and evaluation of a number of materials, including a teaching portfolio, letters of recommendation from department chair, faculty and students, and student evaluations. Having been raised in the United States bilingually and bi-culturally, **Dr. Ewa Wampuszyc** teaches Polish language, literature and culture to foster an active appreciation of this country's ethnic and racial diversity. Polish classes attract a wide variety of students – from those with no previous exposure to the language or culture, to heritage learners who are in search of an intellectual dimension to their ethnic roots, to graduate students whose interest in Poland holds

an academic purpose. Considering the breadth of students' needs, Dr. Wampuszyc strives to create a forum where students learn to critically read and understand a variety of texts. Her goal is to teach students how to identify cultural differences and parallels; to sharpen their analytical tools; and to access resources necessary for thoughtfully and knowledgeably interpreting the world they inhabit.



The Scholarship Enhancement Fund is available through University of Florida's Research and Graduate Programs. It is designed to stimulate new or existing creative or research activity by University of Florida faculty in the humanities and fine arts departments. Approximately forty awards are supported annually, with a maximum award of up to \$10,000. **Dr.** 

**Christopher Caes** won this award for a project titled "Recreation, Material Culture, and Socialism as Modernity in

Poland, 1945-1989." Dr. Caes' research focuses on Stalinist and post-Stalinist mass culture in Poland in order to challenge the dominant cultural and political narratives of this period. Both the official rhetoric of the early communist state of the 1950-60s and the cultural memory of the popular struggle against communism of the 1970-80s agree that what was being accomplished under socialism was the total reconstruction of society according to Marxist-Leninist principles. Artifacts of everyday life and popular culture tell quite a different story, one of often *ad hoc* and contradictory practical implementations of communist cultural policies and popular appropriation and negotiation of official discourses

in the interests of alternative (not necessarily oppositional) practices of consumption and recreation. By focusing on the issue of recreation, Dr. Caes hopes to produce a richer and more variegated account of life under socialism, and finally, to illuminate the contours of a specifically "Second World" modernity that is not identical to the dominant political or oppositional frameworks through which the communist period continues to be viewed.



In turn, **Dr. Hana Filip** was awarded the Scholarship Enhancement Funding for the "Comparative Study of Systems of Aspectual Representation in Slavic, Germanic, Romance Languages and Modern Hebrew." The goal of Dr. Filip's research project is to investigate the expression of aspectual distinctions in the aforementioned languages. Assuming that aspectual distinctions are semantically universal, a central question is how languages with very different grammatical structures represent these semantic distinctions. Dr. Filip proposes to explore this via thorough case studies of several languages from four typologically distinct language families, and with very different morphological representations of aspectual properties.

We wish to take this opportunity to congratulate Drs. Wampuszyc, Caes, and Filip on winning these prestigious awards.

### **New Library Acquisitions**



The Center for European Studies partially sponsored the library purchase of two valuable microfilm databases, Dissent in Poland: Publications and Manuscripts from the KARTA Center Foundation Archives in Warsaw, Poland, and the Foundations of Modern Europe microfiche collection. Both databases are published by Thomson Gale.

CES acquired the first two of the three parts of the KARTA database, the Opposition, Solidarity and Eastern Archives. The KARTA began in 1982 as an illegal publication during Poland's period of martial law. After 1989, it evolved into a non-governmental archival repository that set the goal of preserving memories of events and people that were not likely to be represented in state and regional archives. The Opposition Archive documents the various stages of Polish opposition to Communist rule between 1956 and 1989, illuminating its key moments. It is composed of primarily individual memoirs, diaries, and tape recordings, but also includes reports, publications, thematic collections, maps, and drawings. The Solidarity Archive, in turn, focuses on the sixteen-month period from the founding of Solidarity in September 1980 to the imposition of martial law in December 1981. This collection traces Solidarity's emergence from a strike movement and the formation of factory and shipyard strike committees through minutes of meetings, organizational statutes/constitutions, proclamations, manifestos and pamphlets.

The Foundations of Modern Europe contains administrative and organizational papers related to the movement for united Europe including press releases, financial documents, minutes of meetings, conversations, correspondence, and papers of influential post-war politicians and diplomats such as Jean Monnet, Robert Schumann and Paul Henri Spaak. These materials illuminate the process of

rebuilding post-war Europe and the establishment of cooperation between European countries. The collection also illustrates the emergence of the concept of the European federal model in contrast to American federalism by tracing the rise of the European Community during the Cold War, the development of modern Europe, her political allegiances and monetary-economic policies. Finally, the archives contain important references to the complex diplomatic and political issues which dominated post-war Europe and the Cold War years through the 1940s and 1950s, ranging from the Marshall Plan and the Berlin Blockade to the Greek civil war, the Coal and Steel Community, and German entry into NATO. These archives will assist scholars conducting research on the rebuilding of post-war Europe, the establishment of European political and economic institutions and the differences of American and European federalism, to name a few.

# **CES Signs Agreement Establishing a Language Testing Center**

The Center for European Studies signed an agreement with the University of Pecs in Hungary for the establishment of a testing center for the following languages: Hungarian, Polish and Czech. According to this agreement, the CES will be able to conduct proficiency exams following the criteria of the European Consortium (ECL), and those who pass the exam will receive a Certificate of Attainment in Modern Languages. As a US institution, the University of Florida cannot directly participate in the Consortium but will be accredited through the University of Pecs. The Center for European Studies will receive the examination

materials from Pecs and after conducting the exams send them back to Pecs for evaluation. The University of Pecs will then issue the certificates.

The agreement and the guidelines for establishing a testing center have been reviewed by the CES Language Coordinator in order to ensure the fulfillment of requirements for conducting language exams. The Center for European Studies is responsible for fulfilling all personnel and material requirements necessary for the organization and administration of the exams; ensuring that test materials are handled with care and confidentiality; training

**NEW!** Study Abroad Program in Pécs and Budapest: The UF in Pécs and Budapest Program offers students an opportunity to earn six credits at the University of Pécs (*Hungarian Language in Action* and *Hungary at the Crossroads*, taught in English). Students will spend four weeks in Pécs and two weeks in Budapest. Cultural excursions are also planned in the vicinity of these two cities and around Lake Balaton, the largest lake in Europe and the location of Hungary's many cultural sites.
