### Summary:

*“If I were to do it again from scratch, I would start with culture.”*

is a phrase attributed to Jean Monnet, one of the EU’s founding fathers.

It is quoted ceaselessly. The catch is that Jean Monnet never actually said that.

Nevertheless, the last two decades have seen a flourishing of investments in culture, from government support for libraries over language policies to creative industry incentives.

In what sense can we speak of an EU 'politics of culture'? How is 'Culture' understood as a policy realm? And what are the policy goals of this 'politics of culture'?

'Culture' is generally endowed with integrative powers. It articulates individual and collective differences, values and practices. The traditional linkage of cultural institutions, media and public arts with social governance and the encoding of collective identities means that far from just talking about 'intellectual and aesthetic practices, EU politics of culture establishes linkages between culture and citizenship and EU identity, the EU as a 'demos', and EU legitimacy. Moreover EU concern with the straddling of diversity and cohesion also means that 'inter-culture, or 'cultures', has emerged as a cultural policy domain, couched in terms of interfaith and intercultural dialogue. How do the supranational, national, regional, and the local interface in these initiatives?

In this course we will examine and analyze the development of 'culture' as an EU terrain of politics, examining specific EU policy initiatives across a broadly understood concept of 'culture.'

### **Learning objectives:**

By the end of this course students will have a broad understanding of key debates about culture and Culture, European identity, community, identification and belonging, modernity, Eurocentrism, integration, Europeanization and globalization.

### **Format:**

The course will consist of lectures, structured discussions and in class activities, including student research projects and presentations, as well as presentation of audio-visual material.

**EXPLANATION:**

**ATTENDANCE AND PARTICIPATION: 5% of your grade**

**Explanation:** This course will be conducted in seminar format. To ensure active learning you are required to submit your answers for the reading questions to each module before that week's online sessions. Absences from class must be properly documented. An absence without proper documentation will be counted as an unexcused one. Two or more unexcused absences will result in lowering of your attendance and participation grade.

**PRESENTATIONS: 5 % of your grade**

You will each do a group presentation on one of the weekly modules and an individual presentation on your final research project.

**READING QUESTIONS: 25 % of your grade**

The reading questions that you are asked to complete **EVERY MONDAY** are designed to guide your reading and facilitate discussion.

Reading questions late submission policy: Unless otherwise agreed with the instructor, late submissions will be graded according to the grading rubric.

**PROJECTS ( 2 Reflexivity essays): 10 % of your grade**

You have been assigned 2 projects where you will collect visuals in the form of photos or video to illustrate concepts from the reading for that week. You will explain your rationale for selection the images in a short paragraph and upload your contribution so that we can use them as basis for discussion.

Projects late submission policy: Unless otherwise agreed with the instructor, late submissions will be graded according to the grading rubric.

### **MIDTERM ESSAY: 25%** of your grade

The essay (4-5 pages; 1200-1500 words (minus reference page), double spaced 12 point font) will be based on an essay prompt.

The **Due Date** for the Midterm Essay is **October 21**

**Midterm Essay late submission policy:** Unless otherwise agreed with the instructor, I will deduct half a grade point **from your total score for every 12 hours the essay is late.**

### **FINAL RESEARCH ESSAY: 30%** of your grade

The essay (7-8 pages; 2100-2400 words) (minus reference page), double spaced 12 point font) will be based on your own research.

The **Due Date** for your Final Essay is **December 14**

**Final Essay late submission policy:** Unless otherwise agreed with the instructor, I will deduct half a grade point from your total score for every 12 hours the essay is late.
