

EUS 4932/EUS 6932: Comparative Minorities in the EU

Course Description: Often trapped between the competing logics of nation and state, minority groups in Europe have played an important role in the twentieth century's greatest conflicts and tragedies. At the same time, contemporary Europe offers a substantial institutional approach to minority issues.

This course looks at the role of minority groups in Europe from complicated relationship with the global human rights agenda to the competing claims over politics, resources and cultural rights that persist throughout Europe. We will look at the rise of minority rights, the establishment of the European minority rights regime, and the relationship between national minorities and migrants in contemporary Europe. Furthermore, the course will examine minority issues from a comparative perspective to shed light on challenges that face European societies at large.

A Note on Meeting Time: The course runs the whole semester but it will only meet for the period of two weeks (a total of 30 class periods) and it has been scheduled for periods 11-E2 (6:15pm-9:10pm). Dr. Galbreath will be on campus between March 22 and April 1 and his schedule is quite flexible; the Center for European Studies will work with the registered students to come up with the best possible office hours. Students will need to complete the readings in advance.

A Note on Variable Credit: The number of credit varies from 1 to 3 and it will be assigned based on the student preference and the amount of work completed as follows:

- 1 credit = active participation in class and final workshop on March 28, 2011 plus completion of exam covering the assigned readings;
- 2 credits = all of the above and in addition in-class presentation and a short 5-7 page final paper due April 20, 2011 the last day of the Spring 2011 semester;
- 3 credits = all of the above except final paper will be 20-25 page research paper due April 20, 2011 the last day of the Spring 2011 semester.

20% of the final grade comes from participation in final workshop

20% of the final grade comes from Exam covering the assigned readings

40% of the final grade comes from Research paper
